### **Business Owner Wine Pouring Instructions**

### Your Participation Fee covers the following services provided by the Danville Area Chamber of Commerce and the Danville Livery:

- 1. State of California Alcohol Beverage Control One Day Wine License. This license may be revoked summarily by the Department if, in the opinion of the Department and/or the local law enforcement agency, it is necessary to protect the safety, welfare, health, peace, and morals of the people of the State.
- 2. All guests will come with their wine glass and a wristband which indicates they have paid and are over 21 years of age.
- 3. Post a "No wine beyond this point" sign.

### What YOU need to provide to set up for winery and wine tasters:

- 1. Small bites for guests (contact local restaurants to provide bites for cross-promotion)
- 2. Table for wine, table cloth, **ICE**, ice bucket and towel
- 3. Door monitor to see that the guests do not leave with wine in their glass
- 4. Wine bucket for people to pour unwanted wine

### **Public Safety Requirements:**

- 1. Vintners are to pour 1-oz pours only to those bearing the proper wristband for the 17th annual Spring Sip & Stroll.
- 2. Do not leave wine unattended and do not let people pour their own wine.
- 3. Post "No Wine Beyond This Point" sign and assign a door monitor to check that guests do not leave premises with wine in their glass.

- 1. The wineries and vineyards will bring their wine on Thursday, April 14, 2022.
- 2. Wristbands will be sold Online. Click Here to Purchase Your Online Event Tickets
- 3. Wristbands will also be sold the day of the event by the Danville Area Chamber at two check-in locations:

**Downtown:** Veterans Memorial Building – 400 Hartz Avenue, Danville

Danville Livery: Barnyard Epicurean— 400 Sycamore Valley Road West, Danville

- 4. Merchants will not be selling wristbands. Cost is **\$40** per person Online at Eventbrite through April 8th and **\$50** per person at the door. Designated Drivers are **\$15** per person.
- 5. Commemorative wine glasses will be provided to the guests when they purchase their wristband.
- 6. Vintners are to serve ONE 1-2 oz. pours only to those wearing a wristband. The wristband confirms they have paid and are of legal age. One tasting per person.
- 7. All wine is to be consumed inside the business owner's store and you must post a "No Wine Beyond This Point" sign at your door so guests can easily read it before exiting.
