Business Owner Pouring Instructions

Your Participation Fee covers the following services provided by the Danville Area Chamber of Commerce:

- 1. State of California Alcohol Beverage Control One Day Wine/Beer License. This license may be revoked summarily by the Department if, in the opinion of the Department and/or the local law enforcement agency, it is necessary to protect the safety, welfare, health, peace, and morals of the people of the State.
- 2. All guests will come with their tasting glass and a wristband which indicates they have paid and are over 21 years of age.
- 3. Post a "No Alcohol Beyond This Point" sign.

What YOU need to provide to set up for wine and beer tasters:

- 1. Small bites for guests (We encourage you to contact local restaurants to provide bites for cross-promotion)
- 2. Table for wine or beer, tablecloth, ICE, ice bucket and towel
- 3. Door monitor to see that the guests do not leave with alcohol in their glass
- 4. Bucket for people to pour unwanted wine or beer

Public Safety Requirements:

- 1. Vintners / Craft Breweries are to pour 1-oz pours only to those bearing the proper wristband for the Flavors of Fall event.
- 2. Do not leave alcohol unattended and do not let people pour their own alcohol.
- 3. Post "No Alcohol Beyond This Point" sign and assign a door monitor to check that guests do not leave premises with wine or beer in their glass.

- Merchants will not be selling wristbands. Cost is \$55 per person Online at Eventbrite through October 17th and \$65 per person thereafter. Designated Drivers are \$15 per person.
- 5. Commemorative tasting glasses and wristbands will be provided to all paid guests.
- 6. Pourers are to serve 1-oz. pours only to those wearing a wristband. The wristband confirms they have paid and are of legal age. One tasting per person.
- All wine and beer must be consumed inside the business owner's store and you must post a "No Alcohol Beyond This Point" sign at your door so guests can easily read it before exiting.
